Annual Congregational Meeting Minutes

June 11, 2023

- 1) Certification of Quorum
 - a) Connie Niessink, Vice President, established that the quorum standard had been met.
- 2) Opening Prayer Pastor Wes Smith
- 3) Call to Order
 - a) The meeting was called to order at 10:48 a.m.
- 4) Adoption of Agenda
 - a) The Agenda was contained in the Annual Meeting Packet provided prior to this meeting. The order of the agenda is specified in bylaw C10.01.04. Adopted as written.
- 5) Pastor's report
 - a) In addition to his report in the Annual Meeting Packet, Pastor Wes Smith thanked the congregation and staff, highlighted the new members, the baptism, the confirmands, and the death of a member, and stated his goals for the new year: small groups, and filling MMLT fellowship and stewardship positions (with stewardship shared among 3 or 4 people).
- 6) Officers' Reports
 - a) President's report: Jamie Stewart, President, thanked Becky Porter for her advice and support; she highlighted the accomplishments of the Governance Board for the year; she thanked Jeannie Phillips, who was instrumental in the strategic planning process; Jamie also thanked Bob Behrend for all the work he did reviewing the Constitution; she mentioned the construction as part of the Master Plan; and she thanked Candace Berger and Christina Merriott for their help throughout the construction. The President's full report was in the Annual Meeting Packet.
 - b) Secretary's report: Bill Beck, Secretary, could not attend this meeting. The minutes of the June 12, 2022 meeting were approved unanimously.
 - c) Treasurer's report: Cindy Cannedy, Treasurer, incorporated her report, with the presentation of the budget for 2023-2024, in the Annual Meeting Packet.
- 7) Preschool Board, Preschool, and MOPS reports:
 - a) Preschool Board: Cheryl Kussow spoke of the history of the program, which is now a Level III preschool. She mentioned the success of grant proposals, the work done with safety policies, the task force to establish the relationship between preschool and church, and the on-going interest in substitute staffing.
 - b) Preschool: Melissa Woldman, Director, whose report is in the Annual Meeting Packet, spoke of the joy of the preschool mission. She thanked the Pastor, Staff, and Preschool Board for the work they do and the help they provide. The success of grant applications has allowed many improvements, with the paving of the parking lot to be done imminently, and that they are waiting to hear about another grant. Only a few openings remain for the 2023-2024 school year.
 - c) MOPS: Whitnie Bauer, Coordinator: The report was in the Annual Meeting Packet, and Whitnie added that the group has grown, since Covid, to 30 moms. MOPS is important to them especially because of the community they provide for each other.
- 8) Governance Board Reports
 - a) Jamie Stewart thanked all, and Becky Porter in particular, without whom she said she could not have done the job of president; spontaneous clapping occurred for Becky Porter.
 - b) Team reports were included in the Annual Meeting Packet.
- 9) Mission Ministry Leadership Team (MMLT):
 - a) Ted Kussow thanked Pastor Wes and all the team leaders in the network: Angie Eugenio and Chris Emsley, Service network; Sue Haughton, Worship and Music; John Burkhardt and Brian Hardesty, Property; Jeannie Phillips, who has recently taken on Faith Formation; we are all thankful for Rhonda Blacklock, director of music. He welcomed incoming Candace Berger to the Service network, and Angie Eugenio, returning again.
- 10) Preschool Task Force: Becky Porter:
 - a) Becky gave a short history of the preschool and its relationship with the church. The task force, which continues to meet, will develop recommendations about optimizing this preschool-church

relationship so that both entities can thrive. Members include Cheryl Kussow, Anne Behrend, Jen McKinzie, Connie Steinhart. Scott Herbst, and Becky Porter.

- 11) Unfinished business. There was no unfinished business.
- 12) New business
 - a) Elections: The nomination team's slate of candidates for Governance Board, Audit Team, Endowment Team, Columbarium Team, and the Nominating Team for next year was printed in the Annual Meeting Packet. No nominations came from the floor. Deb Holbrook moved to accept the slate by acclimation. Tom Jones seconded. Unanimous vote was in favor.
 - b) Budget: Cindy Cannedy's prepared budget, pages 8 and 9 in the Annual Meeting Packet, generated questions about grant money (which, clarified, was used to create the Master Plan; no money remained), other grant money from the preschool (clarified as no grant money went into church funds), and what we would need to add to our pledges to compensate for the \$13,000 deficit (about \$130 per pledging unit). After discussion, Tom Jones moved to adopt the budget. No second was needed. Unanimous "aye" vote.
- 13) Other new business: Changes to Constitution, Bylaws, and Continuing Resolutions
 - a) The summary of proposed changes as required by the ELCA was in the Annual Meeting Packet. Connie Niessink moved to adopt the first three items; no second was required; the vote was a unanimous "aye". Connie Niessink moved to accept the changes to model our language, which again received a unanimous "aye" vote. Connie Niessink moved to accept changes to the format of the bylaws, and again the positive vote was unanimous.
 - b) Paul Schmidt asked the Governance Board to reconsider the deletion of the staff support team and to re-instate it. After significant discussion in favor of re-instating the team, John Burkhardt seconded. Discussion included that the staff support team is a two-way street, providing support to both staff and congregation, and when the team is in place, it can avert and deal with issues on both sides. The vote was unanimously in favor of the Governance Board's reconsidering the reinstatement of this team.
 - c) Tom Conrad asked about varying our worship services, to add drama, different liturgies, music. Jim Holbrook added that he would like more instrumental music in services. Sue Haughton, from the Worship and Music team, said they have been discussing this very issue. Barb Burkhardt encouraged interested people to join the Worship and Music team.
 - d) Angie Eugenio apologized for the inadvertent omission of the "In the Loop" group from the Service network report, pointing out the valuable mission of this group that Danielle Burrus and Carol Smith began.
- 14) Benediction: Pastor Wes Smith
- 15) Adjournment: the meeting was adjourned at 11:57 a.m.

This past year has seen an increase in membership (10), beautiful children brought into God's family through the waters of baptism (5), and one of our dearly beloved entrusted into God's Kingdom through death.

Preschool:

Our program has a few spots left for the 24/25 school year, but we have confidence it will be full by August. We are currently searching for one more staff to help cover the Toddler classroom. We have successfully passed all our inspections this year and have maintained our level 3 paths the quality rating. 75% of our staff have a child development associate degree or higher. All staff are working hard towards their 20 hours of developmental training this year and have participated in several virtual early childhood conferences. We have had many successful well attended events this year including our Christmas worship program, Donuts with grown-ups, Pre-K graduation and bike race, and Field Day. Currently applying for a few more grants this coming year and was blessed with several this past year which helped us increase our Chapel and school library.

Organization Reports

Christ Lutheran Church Preschool Board

Mission of the Ministry

The purpose of the Board is to support the preschool, director, and staff in carrying out the mission of the preschool. The Board is responsible for safeguarding the integrity of the organization, and also serves in advisory and advocacy capacities. Areas of involvement include spiritual direction, programming, communication, finance, policy development and additional areas as needed or desired. The Board serves as the primary conduit of information between the director, the governing body of the Church, and members of the congregation.

Progress of the Ministry

- We have welcomed Connie Niessink as the Gov Board President representative on our Preschool Board. It has been very helpful for communication and coordination between the two boards.
- We continued to be blessed by a Grant obtained by Melissa for literacy (\$5000). We have also applied for another \$100,000+ grant and should find this summer the status. We appreciate our Path to Quality Level PTQ level 3 status (safety and educational quality) that allows us to apply and the United Way, Lilly Endowment, Office of Early Childhood and Out-of-School Learning for offering these. Because of being PTQ L3 for 10 years we received a \$1000 grant also.
- These grants supported special events for the staff and families: The Family Day offers free food from Grace Truck, free books from the mobile Library, Parks Dept Creek Stompers, activities and fun music by Mr. Dan. The new blacktop in the back parking lot is safer and smoother with better drainage to reduce falls. The school grants allowed us to purchase additional faith formation material and literacy resources especially for our non-native English speaking families.
- Congregational connections are occurring. We have had some families come to attend our Church and MomCo (Mops) and their children attend Sunday school and VBS. Several families asked if they could use our sanctuary for prayer. Our prayer quilt ministry provided a quilt for a former preschool child who has cancer. Many preschool children have attended our St. Nick and Easter Egg hunt. We were able to offer a parent night (childcare) for several of our Preschool and MomCo (Mops) families.
- Approved new policies and discussed activities related to collection of summer tuition, document retention, new custodial services and oversite by Melissa, tuition review in local area, increased tuition and registration fees to cover an increase potentially in the Church tithe (due to rising costs of utilities, supplies, ...) and also charges for late pickups and drop-in care. We were also able to install special classroom door locks in case of an active shooter incident.
- Expressing gratefulness for all the support the Church and parents gave such as Anne Behrend
 volunteering to help with preschool operational accounting and Roger providing Law consultation in
 addition to their roles on the Board. Also, the many people who spread mulch and donated items and
 money for tuition assistance. I appreciate all board members for working with the Governance Board
 task force to explore our governing model and all considering our partnering ministry especially
 Jennifer who crosses between both.

How Can you Help?

Tuition Assistance Donations: We appreciate the many people who have donated to our tuition assistance fund for families in need. We have averaged needing over \$\frac{\$10,000/yr in requests,}{\$}\$ so we pray for your continued support, so we do not need to utilize operational funds and detract from our educational spending and staff compensation. Because of PTQ level 3, on being On My Way Pre-K and CCDF providers we have helped some families also get government childcare assistance.

Substitutes and Teachers: As an ongoing request, the preschool is always in need of substitute teachers to ensure a high standard of care for children when the regular teachers are absent. In addition, periodically we are in need of additional staff. Please consider a 4 or 7 hour paid opportunity or share this need with others you know who might be interested. We also have administrative needs that are paid/or volunteer. We follow the Zionsville school schedule which is a benefit. We also pay for 20+ hours of continuing ed. Thank you!

Vision for the Ministry

- Continue to encourage Church membership and parents to support families with tuition assistance donations so that they can afford quality Christian education for their child.
- Update the Board policy and procedure manual to reflect any changes to our governance structure, and revisions that align with our vision, Director and approve additional draft policies.
- Participate in a more in-depth Strategic Plan exercise with board, Church, staff and families.
- Determine the impact of faith opportunities on children and classroom inclusion. Review current spiritual goals for children's development and support additional staff faith training. Provide more visual reminders of our Christian focus.
- Improve Church/School engagement. Implement mentoring ministry between congregation and young families or parenting seminars or bible studies for families with young children.
- Finalize revised/new finance policies and procedure proposals with Governance Board and Finance team as part of our governance discussions and revised charter.
- Maximize utilization of grants available through 2024 and obtain additional as needed to improve our educational and outreach ministry and support an aging facility (heating/cooling).
- Increase awareness of teaching and sub positions to better support the school when staff is sick or unavailable or we are in need of new teachers.

Progress of the Ministry

This was my third full year as the Director of Christ Lutheran Church Preschool and what a great year it has been. My bonds with the staff and families are growing and we were able to spend more time together in fellowship throughout this year. Our staff changes slightly year by year, and this year we have gained some wonderful ladies to support our mission.

- The program remains mostly full, and families are excited to return next year.
- We are possibly losing 2 staff this year (going back to college and internship) so we are actively searching for new staff to join our team.
- CLCP is talked about with the highest praise on social media outlets by our current and past families.
- Summer Camp is slowly filling up for the 2024 summer.
- We have successfully passed all our inspections this year and have maintained our level 3 paths to quality rating.
- 75% of our staff have a Child Development associate degree or higher.
- All staff are working hard towards their 20 hours of development training this year, and participated in several virtual early childhood conferences, and we also brought in a team of trainers.
- Chapel has continued twice weekly in our sanctuary, a few teachers have helped me out with Chapel this year, and Cheryl K. has helped with many ideas which is always appreciated.
- Successful Christmas program, Donuts with grownups, ice cream social, Pre-K graduation, Pre-K bike race, and Field Day events this year, looking forward to many more next year.
- Received several small grants this past year, which helped increase our Chapel and school library.
- Currently applying for another grant and awaiting word on one that I have already submitted.

Vision for the Ministry

- Retain current staff and families in the coming years and continue the reputation we have in the community.
- Continue to strengthen the relationship between the Church and the Preschool by offering more activities for the congregation and preschool to be together.
- Continue to improve and implement more family engagement activities. Applied for a grant to help with this.
- Continue to research grant opportunities to improve our program and church.

MomCo formerly MOPS (Mothers of Preschoolers) 2024

Mission of the Ministry

MomCo is a ministry to mothers of young children. We provide a safe space for mothers to bond and form friendships, explore and deepen their faith, and also listen to speakers on various topics relating to her as a woman, a mother, a wife, and a Christian.

Progress of the Ministry

This was my third year as the Coordinator for our MomCo/MOPS group. We've seen a resurgence in attendance following our "Covid years", and had close to 25 moms and 2-3 childcare rooms at each meeting.

- We've welcomed about 5 new moms into our group this year, and helped care for their children during our meetings as well.
- At our last meeting in May, we had 12+ registrations submitted with payment already for the '24- '25 year.
- We were able to accommodate all the children registered to attend our childcare last year, and
 even were able to provide a baby room when needed (many babies graduated to the toddler 1
 room). We hope to continue to build our childcare roster and have a baby room available at all
 times. We maintained the state ratio of children vs. caregivers at each meeting.
- This year we learned about personal growth and how it affects our mothering, had a visit from a local OB/GYN NP to discuss women's health matters, local Christian author Marianne Miller also visited us and taught us some lessons in saying no to children. In the new year, we learned about personal finance from a Christian financial planner, we celebrated our community with a "Galentine's" themed meeting. In March, which is National Disability Month, we learned about what its like to parent a child with special needs and what they want us to know and how to approach them. Lastly, we had a delightful visit from Cheryl Kussow who spoke about the Fruits of the Spirit and helped us arrange flowers. We closed the year with introducing the new name/theme, preregistering moms, and preparing for summer.
- Comments from our end of year survey submitted at our last meeting:
 - "Your service is blessing the lives of so many thank you!".
 - "A relaxing time with other moms in the same season of life".
 - "It's a wonderful place to build connections and a community of women in the same boat as you"

Vision for the Ministry

- Retain current members and continue to recruit new members.
- Strengthen our bond with the church community by offering MNO activities for working mothers to attend (social membership), finding Mentor Moms from the church community to commit to attending a couple meetings with us, helping man the baby care tent at the Fall Festival, etc.
- Continue to offer quality and relevant speakers and meeting topics for our moms.
- Continue to offer quality childcare for our MOPPETS and provide them with fun and engaging lessons on Christ.

Ministry Team Name: Endowment Fund

Mission of the Ministry

The 7 members of the Endowment Team met twice during the current fiscal year. The Charter was updated to reflect new policies.

Progress of the Ministry

The Team may allocate grants (a maximum of \$1000 each) to members of the congregation which will benefit the congregation, enhance its mission and/or provide social services for those in need in our local communities. Grants will not be allocated for operating expenses.

Grants may be allocated up to 4% of the Balance on January 1, of the fiscal year, which was on January 1, 2024, \$90,000. (There have been \$10,000 in grant disbursements since the beginning of the fund.)

Metrics Highlighting Achievements

The current Balance of the Endowment is \$100,000. The balance on April 30, 2023, was \$85,000 Since the inauguration of this fund, \$40,000 has been donated, the Principle, which cannot be invaded, thus representing the gifts which are protected in order to create income which is used to distribute for grants.

Vision for the Ministry

The Team has committed itself to regularly remind the congregation of this opportunity to make lasting gifts on behalf of special occasions, loved ones, etc., and the opportunity to apply for and receive funding for worthwhile projects which further the mission of our congregation.

Mission of the Ministry

Our mission is to inform the congregation of service opportunities to our church family, our community, and to global missions. We seek to enlist the help of congregational members in leading and performing these acts of service.

Progress of the Ministry

Service to the congregation:

- Organized, provided and served meal following the funeral service for Georgi Schroeder. 60+ people were served.
- Provided and served meal before the Lenten service on February 21st.
- Prayer chain led by Donna Svobada. The prayer chain has continued to support requests for prayers of congregation members, family, and friends.
- Organized and supported the meal chain for two new births within the congregation: Bode Bergman and Nolan Smith.

Service to the community:

- Contributed to the Shalom House's summer lunch program.
- The spring blood drive was held April 14th. Christina Merriott gave a brief temple talk the 7th to encourage donations. We had 13 whole blood units and a double red cell which I was told should translate into enough at 3 people per unit should help over 50 people. The fall drive is currently scheduled for November 24th.
- Sixteen volunteers set up and hosted the baby care tent which served 30 families at the Lion's Park Fall Festival on Saturday and Sunday.
- Donated 641 pairs of socks, 26 scarves and 31 hats/hand warmers to the Wheeler Mission through our Socktober community drive.
- Through the annual Christmas giving tree, delivered over 100 items in gifts and gift cards to LCFS for their Christmas store.
- Elsie's Circle has provided several prayer quilts for members of our congregation and our community. Members can request a prayer quilt for anyone who needs prayerful support. Contact: Linda Callecod.
- The Blessing Box was rescued and re-deployed on CLC property this past fall and is already supporting those in need in our community with basic emergency food needs.

Service to global missions:

Progress of the Ministry

- Our ministry has grown as new families have joined our church and we continue to engage
 preschool and MOPS families. Our Sunday education program now includes Faith Stepping Stones
 which is an opportunity for families to join their children to learn about important milestones in
 their faith journey such as the Lord's Prayer and the sacrament of Baptism, both of which were a
 focus this year. It is worth mentioning that any child who joins the Sunday education hour is given
 a free Bible to take home.
- With an all-volunteer staff, we have focused on doing a few events and activities well vs adding new ones. These include Vacation Bible School (VBS), Breakfast with St. Nick, Parents Night Out, and the Easter Egg Hunt. In addition to serving our church families, these activities include a significant outreach and evangelism component so that we can share God's love with families outside of our church.

Achievements of the Ministry

- Up to 15 children and 10 adults participated in our Sunday Education hour (25% increase vs 2023)
- 5 members once again gave children's sermons
- 40 volunteers helped prepare for and carry out Vacation Bible School for 35 kids
- 115 people joined us for Breakfast with St. Nick as either volunteers (35) or guests (38 adults, 42 kids)
- 23 volunteers helped give our CLCZ, preschool and MOPS parents a night out while they took care
 of 38 kids in February
- 111 people including children (46), adults and volunteers joined us for the Easter Egg Hunt
- Our high school and middle school youth baked Thanksgiving pies for people in need and helped with VBS, Breakfast with St. Nick, Parents Night Out and the Easter Egg Hunt.

Vision for the Ministry

- We have an opportunity to step up the engagement of our youth. In addition to upgrading our Youth Room, we are partnering with Fellowship to plan social activities such as Indians games, Pacer games, game nights, etc. See Kristen's report. It is an honor and a joy to report to you on the Music Ministries of Christ Lutheran Church. The Sanctuary Choir has grown from 19 members to 22 members. Our choir season kicked off with a retreat at Zionsville Town Hall on August 26th, where we spent the day meeting our new members, singing a lot of new music, working on our Christmas cantata, playing music games and enjoying fellowship together. The choir presented John Leavitt's "What Child is This?" during our worship services on Sunday, December 17th, with a small chamber ensemble to accompany the work.

Celebration Bells is at capacity with 13 ringers. This season we were graciously gifted an additional 2 octaves of Malmark handchimes, so the choir now has 5 octaves of handbells and 5 octaves of handchimes. The additional chimes have greatly added to our repertoire; they have also increased the skills of those who ring the really low bells and the very highest bells. In December, we attended a "Ring and Share" event at Cross of Grace Lutheran Church in New Palestine, IN, where we heard beginning school choirs, existing church choirs, community choirs and small ensembles play music that they were working on for worship or programs at their school or in the community. We played "Sing We Now of Christmas", a standard piece in the handbell repertoire.

Kantorei continues to serve in a less rigorous rehearsal/worship schedule. We continue to offer shorter term singing opportunities for men's ensemble (Fortress) and women's ensemble (Musae) during the summer months.

In the coming year, we would welcome any new singers to Sanctuary Choir. No audition is needed and singers of all ages are welcome to join. Rehearsals are on Wednesday evenings at 6:30pm. Celebration Bells is full, but would welcome ringers as substitutes or who may be interested in forming a new choir! Rehearsals for Celebration Bells are on Thursday evenings at 6:30pm.

Additional Small Groups

Altar Guild

The Altar Guild is the mighty "behind the scenes" volunteers who prepare and clean up communion each Sunday, keep the font cleaned and filled, put oil in the candles, make the baptismal banners and change the big banner, paraments and mosaics to reflect special Sundays and seasons of the church year. They are also responsible for decorating the narthex and sanctuary at Christmas and Easter. In addition, they make sure that any sponsored flower arrangement is made.

Presently we have 14 wonderful and dedicated people who serve on Altar Guild. They are Barb Burkhardt (coordinator), Andi Hardesty, Deb Gates, JoAnne Tuffnell, Connie Ashenfelter, Chris Emsley, Connie Steinhart, Linda Callecod, Barb Starkey, Gretchen Jeffers, Sue Haughton, Margie Kilgus, Jen Luczak and Tom Jones (banners).

The members chose what months they can serve and a team of 3-4 members are assigned for each month. They coordinate within themselves, whether they want to do the communion preparation or clean-up and create their own schedule so that all the needed monthly tasks are completed.

If you have an interest in serving on Altar Guild, a member will train you until you feel comfortable in the procedures. We have only one annual meeting. If you would like to become a member of this congenial group or have any further questions, contact Barb Burkhardt or any altar guild member to express your interest.

CLCZ Book Club

The CLCZ Book Club has been one of the small groups of Christ Lutheran Church of Zionsville for 14 years. It began meeting in the spring of 2010 and continues to meet monthly on the second Thursday of every month at 1 pm, usually at the church but occasionally at a restaurant or in one of the members' homes.

We have 24 members on our roster, but about 10-15 members are able to attend our meeting on a regular basis. We meet from September through May. We select our books by nominating and then voting on books in which members have expressed an interest. Each year's list will usually consist of a mix of fiction, non-fiction, perhaps a biography or memoir. In our discussions we try to look at the social, moral, ethical and religious, if any, issues that the author presents.

Our book club welcomes new members at all times. We have quite a few members who are not members of CLCZ and we are delighted with their presence.

Occasionally the book club participates in a church-sponsored event like a food or clothing drive. We have prompted fellowship events such as the outing to the Broadway in Indianapolis show <u>Come From Away</u> in January 2020.
